Sub: List of provisionally eligible candidates to be called for OMR based written examination for the post of Driver against Advt. No. NCL/01-2021/ADMIN-ISO – reg.

1. With reference to the earlier Notice of even number dated 26.12.2025, CSIR – National Chemical Laboratory, Pune has conducted Skill Test of the provisionally eligible candidates who have appeared as per their scheduled date & time for the post of Drivers at Institute of Driving Training and Research Society, Pune.
2. Out of 158 provisionally eligible candidates, 82 candidates appeared for the Skill Test as per their scheduled date and time.
3. Accordingly, the result of the candidates who appeared for the Skill Test has been enclosed herewith as **Annexure – I**
4. While preparing the list, due care has been taken. However, any inadvertent error cannot be ruled out. CSIR-NCL, Pune reserves the right to rectify any such error at a later stage.
5. All the candidates who Qualified the Skill Test shall be provisionally eligible for OMR based written examination.
6. The Admit cards for the OMR based written examination for only those candidates who have qualified the Skill Test are being sent to their permanent addresses and Email ID as given in the application form. Further, an SMS regarding issuance of Admit Card shall also be sent on registered mobile number of the candidates.
7. The OMR based written examination for the posts of Driver has been scheduled on **18th February, 2026 (Wednesday) in Pune only**. The detailed schedule of the test shall be communicated in due course.
8. The detailed syllabus and scheme of examination for Written Examination was already notified vide CSIR-NCL Addendum dated 12.12.2022 & 05.02.2024 for the post of Driver (Post Code - 05) on CSIR-NCL recruitment website <https://recruit.ncl.res.in> against advertisement No. NCL/01-2021/ADMIN-ISO. The same is also given below:

(i) **Mode of Examination:** OMR Based Multiple Choice Examination.

(ii) **Medium of Questions:** The questions will be set in English, Hindi and Marathi except the questions on English Language.

(iii) **Standard of Examination:** Class 10th/Xth

(iv) **Total No. of Questions:** 100

(v) **Total Time Allotted:** 90 Minutes.

Detailed Syllabus: One paper consisting of four parts as below:

Subject	Topics
General Intelligence	Non-Verbal reasoning, similarities and difference, space visualization, problem solving, analysis, judgment, decision making, visual memory, discriminating observation, relationship concepts, figure classification, arithmetical number series, non-verbal series etc.
Quantitative Aptitude	Fundamental arithmetic operations, discount, percentage, profit & loss, simple interest, time & work, LCM & HCF, time & distance, number system, ratio, average, fractions, decimals etc.
General Awareness	Awareness of the environment around, current events, Sports, History, Culture, Geography, Economic Scene, General Polity including Indian Constitution, Scientific Research etc.
English Language	Basic knowledge of English language, vocabulary, grammar, sentence structure, synonyms, antonyms and their correct usage etc.

9. As per CSIR letter No. 5-1(211)/20 14—PD dated 30.05.2023, the Methodology for resolution of Tie Cases wherever two or more candidates have secured equal aggregated marks shall be decided as follows:
- Candidate with lesser negative marks, if applicable, in the papers (which have been considered for preparation of merit) of Written Test placed higher,
 - Date of Birth, with older candidate placed higher,
 - Candidate acquiring Essential Degree earlier placed higher,
 - Alphabetical order in which first names of the candidates appear.
10. **The Document Verification (DV) process shall be carried out for all the provisionally eligible candidates before commencement of OMR based written examination. Therefore, all the candidates appearing for the written examination are required to produce the ORIGINAL and VALID copies of all the following documents, as applicable, that were furnished along with their application form. Candidates must also bring one set of the self-attested photo copies of the documents for submission of the same at the time of DV.**
- 10th/ Matriculation or Equivalent Certificate for Name & Date of Birth Proof.
 - Latest/Valid Community or Category certificates etc., as per GoI central format, in case of SC / ST / OBC (NCL) /EWS / Ex-servicemen (valid Ex-servicemen certificate/Full Discharge book, mentioned in the advertisement), if claimed.

- **Valid/latest driving license** and **original experience certificate** submitted at the time of application.
- Valid Photo Identity proof in original such as PAN Card/Passport/Driving License/Voter Identity card/Aadhar Card with photograph or any other ID proof issued by State or Central Govt.
- Applicants working in Government Departments, Autonomous bodies and Public Sector Undertakings shall be required to produce a '**No Objection & Vigilance Certificate**' in the prescribed format as per attached **Annexure - II**.
- Any other Original document in support of the claim made in the application, as applicable.
