- 1. Total 5017 applications were received within the stipulated date. Out of 5017 candidates, a total of 3905 candidates were found provisionally eligible for Computer based Test (CBT). The final list of provisionally eligible candidates for CBT was issued vide NCL Notification No. NCL/C&P/01-2021/Admin-ISO, dated 19.01.2024
- 2. The Computer Based Test (CBT) Exam for all the provisionally eligible candidates for the post of Junior Secretariat Assistant (Gen/ F&A/ S&P) was conducted on 22<sup>nd</sup> March 2025 (Sunday) at different examination centres in Pune.

Candidates who appeared for the exam were provided their scores as well as answer keys of the Paper-I & II in their respective logins and were given an opportunity to represent/challenge against the model answer key(s).

- 3. Representations received from the candidates with regard to the Answer Keys of Paper-I and Paper II of the Examination were carefully examined and appropriate decisions were taken as notified vide NCL Notice No. NCL/C&P/01-2021/Admin-ISO, dated 09.05.2025.
- 4. The minimum threshold marks in Paper-I & Paper-II, as determined by the Selection Committee were notified vide this office Notice No: NCL/C&P/01-2021/ADMIN-ISO, dated 09.05.2025.
- 5. Paper II was evaluated only for those candidates who have obtained threshold marks & above, as per the CSIR Guidelines. Merit list has been prepared based on marks obtained in Paper II.
- 6. Resultantly, 144 candidates were called for the Computer typing speed Test. The list of such candidates was published vide this office Notice No: NCL/C&P/01-2021/ADMIN-ISO, dated 09.05.2025.
- 7. The Document Verification and Computer typing speed test of the candidates was held on 22<sup>nd</sup> June, 2025 in Pune as per extant CSIR rules and guidelines.
- 8. The Director, CSIR-NCL, on the basis of recommendations of the Selection Committee constituted as per the provisions of CSIR-ASRP Rules, 2020 has been pleased to approve the selection of the following candidates for appointment to the 12 posts of Junior Secretariat Assistant (Gen./F&A/S&P) in Pay Matrix Level-2 of 7<sup>th</sup> CPC advertised vide NCL Advertisement No: NCL/01-2021/ADMIN-ISO.
