1. Total 15,182 online applications were received against 18 vacancies. Out of 15,182 candidates, a total of 14,522 candidates were found provisionally eligible for Competitive Written Examination. The final list of provisionally eligible candidates was issued vide NCL Notification No. NCL/C&P/01-2025/Admin-JSA, dated 20.05.2025.

- 2. The OMR based Written Exam for all the provisionally eligible candidates for the post of Junior Secretariat Assistant (Gen/ F&A/ S&P) advertised vide Advertisement No. NCL/01-2025/ADMIN-JSA was conducted on 8<sup>th</sup> June 2025 (Sunday) at different examination centres in Pune.
- 3. Candidates were allowed to carry the question paper and copy of their OMR sheets. Answer keys for the question Paper-I and Paper-II were made available to the candidates appearing for the examination.
- 4. Representations received from the candidates with regard to the Answer Keys of Paper-I and Paper II of the Examination were carefully examined and disposed-off as notified vide NCL Notification No. NCL/C&P/01-2025/Admin-JSA, dated 15.06.2025.
- 5. The minimum threshold marks in Paper-I and Paper-II, as determined by the Selection Committee, were notified vide this office Notification No: NCL/C&P/01-2025/ADMIN-JSA, dated 17.06.2025.
- 6. The Paper II has been evaluated only for those candidates who have obtained threshold marks & above. Merit list has been prepared based on marks obtained in Paper II.
- 7. Resultantly, 305 candidates were called for the Computer typing speed test (Typing Test). The list of such candidates was published vide this office Web Notification No: NCL/C&P/01-2025/ADMIN-JSA, dated 17.06.2025.
- 8. The Document Verification and Proficiency in Computer typing speed test (Typing Test) of the candidates was held on 29<sup>th</sup> June, 2025 in Pune as per extant CSIR rules and guidelines.
- 9. The Director, CSIR-NCL, on the basis of recommendations of the Selection Committee constituted as per the provisions of CSIR-ASRP Rules, 2020 has been pleased to approve the selection of the following candidates for appointment to the 18 posts of Junior Secretariat Assistant (Gen./F&A/S&P) in Pay Matrix Level-2 advertised vide NCL Advertisement No: NCL/01-2025/ADMIN-JSA.
